

Wacom Cintiq Pro & MobileStudio Pro with Sculptron (3 months) Promotion



TERMS AND CONDITIONS

This promotion is valid only during the Promotional Period (specified below), and is subject to these Terms and Conditions, including without limitation, the eligibility and other requirements, terms, and conditions set forth herein. By participating in the promotion, you agree to be subject to and bound by these Terms and Conditions.

PROMOTIONAL PERIOD

The promotion runs from March 1, 2021, through February 15, 2022 (the “Promotional Period”).

THE OFFER

The following offer is made under the promotion (the “Offer”):

Qualified Purchasers (defined below) who purchase an Eligible Product (defined below) during the Promotional Period may receive a three (3) month license (the “Term”) for Sculptron from OTOY Inc. (<https://www.otoy.com>) (the “License”). Sculptron is available only in the English language and for operation on Windows OS only.

After the expiration of the Term, the License will automatically expire, and the Qualified Purchaser’s rights to use Sculptron will immediately and automatically cease and Sculptron will no longer function. In order to obtain rights to use Sculptron, the Qualified Purchaser must purchase a subscription for Sculptron from OTOY Inc.

The Offer cannot be combined with an existing Sculptron subscription. If a Qualified Purchaser has purchased a subscription to use Sculptron from OTOY, Inc. and would like to receive the Offer, the Qualified Purchaser must terminate or not renew his or her subscription and then redeem the Offer once his or her subscription has expired or been terminated.

Your software release code for the License and a link to download Sculptron will be made available to you in your Wacom Library accessible via your Wacom account (<https://account.wacom.com>). The software release code must be redeemed by February 15, 2022 in order to receive the Offer. Please note that each software release code is unique per end user and is for one time use only.

You may access the software release code by selecting the “Offers” tab in your Wacom Library. You will then be asked to select your preferred operating system. You will then be provided the option to click “Redeem,” upon which the software release code will be automatically ingested in the redemption link and you will be directed to the OTOY, Inc. registration site.

You will need to register with OTOY, Inc. in order to receive the Offer. Please note that OTOY, Inc. will require that you provide your name, physical address, and email address as part of registering with OTOY, Inc. You may also be required to expressly indicate your acceptance of OTOY, Inc.’s Terms of Service and Privacy Policy.
