### **Terms and Conditions**

### **PROMOTIONAL PERIOD**

The promotion runs from January 7, 2020, through June 30, 2020 (the “Promotional Period”).

### **THE OFFER**

The following offer is made under the promotion (the “Offer”):

Qualified Purchasers (as defined below) who purchase an Eligible Product (defined below) during the Promotional Period may receive a two (2) month subscription (the “Subscription”) to Adobe® Premiere Rush (the “Software”), available in the following languages: English, French, Spanish, German, Korean and Japanese. The following Wacom products are eligible for the promotion (each an “Eligible Product”):

No used or refurbished products are eligible for the promotion.

Following the receipt of your confirmation email, your voucher code for activating your Subscription will be made available to you in your Wacom Library accessible via your Wacom account (<https://account.wacom.com>). The voucher code must be redeemed by July 31, 2020 in order to receive the Offer. Please note that each voucher code is unique per end user and is for one time use only.

Once you have obtained your voucher code, please follow these steps in order to activate your Subscription:

2. Sign in with your Adobe ID or sign up to get one;
3. Once logged in, click "Redeem code" and enter your voucher code;
4. Read the renewal terms, enter payment information (optional), and click on "Accept terms and conditions" or "Remind me later"; and
5. Download the Software.

Upon the expiration of your Subscription, you will have no further right to use the Software except as otherwise authorized by Adobe.
